#### **Student Enrollment Information**

Lisa Jamieson, Director of Care & Community for Walk Right In Ministries (WRIM), is an International Representative (IR) for the Sarasota Academy of Christian Counseling (SACC).

While you are a Creation Therapy student, Lisa Jamieson will be your instructor. She becomes your advocate with the SACC and WRIM. The administration of this course (paperwork, certifications, and finances) flows through WRIM.

This is the process you can expect for completing Creation Therapy and Practicum:

- 1. Meet with Lisa Jamieson to discuss your purpose/intent and the Arno Profile System (APS) temperament profile.
- 2. Submit the Creation Therapy (CT) Enrollment Application and fee.

Upon acceptance, we will order your coursework and send it to you.

Note: In the Creation Therapy textbook you receive, there is an APS response form. Please do not complete it as you will have already completed one.

- 3. Study the CT textbook, complete the workbook (including Code of Ethics), and pass two unit exams.
  - a. Each exam (Unit 1 and Unit 2) is 50 true-false questions.
  - b. Exams are taken online and must be proctored by someone who is not a family member.
  - c. When each exam is complete, it is submitted to Lisa Jamieson for grading. You must pass each exam with a grade of 80% or better. (Exams are graded for your benefit; your grades are not recorded. Retakes are an option.)
  - d. After your successful completion of both exams, you will be required to become a member of the Sarasota Academy of Christian Counseling. This requires an application and fee.
- 4. Complete the Practicum by administering the APS with 10 individuals as "case studies."
  - a. Case studies are completed under the supervision of an International Representative. Prior to meeting with your practice clients, you will meet with Lisa Jamieson (or other IR or CAI when arranged in advance) to go over the reports. A minimum of three (3) supervision meetings are required during the Practicum.
  - b. You are not permitted to charge clients for these ten (10) meetings. The cost of APS reports for the Practicum are the student's responsibility. These case studies will be submitted to Lisa Jamieson for processing.
- 5. Apply to the Sarasota Academy of Christian Counseling for membership and pay the application fee.

After you have met all of the requirements to be certified by the Sarasota Academy of Christian Counseling, you will be APS certified to administer and **explain** the APS and may charge fees for your services. If you would like to **counsel** using the APS, you must be licensed, ordained, or certified by your congregation or other Christian licensing organization, and documentation must be submitted.
